

### **Terms and conditions**

#### **Art. 1. Definitions**

- 1.1 **Cromberge | Genealogisch Onderzoeksbureau**: hereinafter referred to as CGO, established in 's-Gravendeel (municipality Hoeksche Waard), The Netherlands.
- 1.2 **Customer:** the person who conducts one or more products.
- 1.3 **Products:** Descendent report (Afstammingsreeks), Genealogy (Genealogie), Pedigree chart (Kwartierstaat) or other predefined genealogical research.

### Art. 2. Privacy

- 2.1 The customer delivers privacy-sensitive data for the purpose of one or more products. CGO will use this data only in the context of genealogical research and never share it with third parties.
- 2.2 All data about both deceased and living persons which are supplied at the request of the customer by CGO are covered by Dutch privacy laws.
- 2.3 The customer is not entitled to publish data on living persons.
- 2.4 The customer is not entitled to publish data on deceased persons without the permission of living relatives.
- 2.5 CGO will not research for or publish on living relatives of an ancestor of the customer.

### Art. 3. Prices

- 3.1 All prices on the site are in EUR.
- 3.2 The prices give an indication of the likely costs.

### Art. 4. Offer

- 4.1 CGO is obliged to offer the customer a customized written quotation.
- 4.2 The tender is binding upon written acceptance by the customer.
- 4.3 The customer will be informed in cases of price deviations,. The client is then allowed to cancel the contract.

#### Art. 5. Cancellation

- 5.1 The customer can cancel a request for investigation.
- 5.2 Costs and hours worked by CGO are charged to the customer.

#### Art. 6. Payment

- 6.1 Payment is effected within 14 days after the invoice date. All payment details are listed on the invoice.
- 6.2 CGO will charge interest if payment is not effected within 14 days and/or enable a collecting agency.
- 6.3 All costs made by the collecting agency will be of charge for the customer.

#### Art. 7. Delivery

- 7.1 The customer shall confirm acceptance of the preview (watermarked report in pdf format) in order to have the final version published in digital format.
- 7.2 Delivery will take place after receival of the invoiced amount on the bank account of CGO.
- 7.3 The delivery will be done via email or letter, unless otherwise agreed.

7.4 In case the products do not reach the customer because of lost in the mail, CGO will send new products to the client.

## Art. 8. Copyright

- 8.1 All reports and images provided from archives and other sources are copyrighted. The customer may only use it for his/her own genealogical research.
- 8.2 The customer requires written permission from the copyright holder to publish the documents presented, for example, a (personal) genealogical website, book or any form of publication.

# Art. 9. Liability

9.1 CGO is not liable for any damage the customer causes by breaking privacy or copyright laws.
